Terms & Conditions

1	The imprest amount will cover expenses for Book, Uniform, Stationary, Outdoor trips/excursion, Laundry, Barber, Personal expenses (like Birthday celebrations, any shopping etc.), Hospitalization expenses, CBSE Fees, ID Card, Farewell, Annual Day celebrations, Fines etc
2	Student has to maintain minimum balance of 5,000 in imprest all the time
2	Breakages and damage to School property, willful or otherwise, is not included, and will be charged.
3	The fee only includes basic medical expenses provided in-house like dressings and OTC type medicines for immediate relief. All medical expenses incurred outside the School towards Doctors, Hospitalization, Medicines etc will be borne by the Parent. For any medical emergency, the student will be taken to Subharti Hospital, located beside the school, while simultaneously informing the parents.
4	A charge of Rs 500 is applicable for dishonored cheques and school will only accept online transfers/cash, thereafter.
5	The Term Fees should be deposited by 10 th April (Term 1) and 10 th October (Term 2). A Late Fee fine of Rs. 100.00 per day shall be levied from the due date, unless there is prior approval. For prior approval, parents must approach the school before the 10 th of the month in which the default occurs.
6	Fees shall be charged for 12 calendar months (April - March) in a session.
7	The Fee is paid as per the School Prospectus and Parents will not receive any reminders for depositing the fee.
8	30 days written notice of withdrawal shall be given to The School Office, failing which a month's fees will be charged.
9	If the outstanding fee exceeds 60 days. The student's name will be removed from the School Roll. Students wishing to continue study at DGS after removal from the School Roll for any reason would need to apply afresh.
10	The school reserves the right to review the fees periodically and the same shall be applicable to all students.
11	The Parent is expected to read and understand all the Policies of the School prior to taking Admission.
12	All disputes shall be subject to competent courts having exclusive jurisdiction in district of Dehradun.
13	The refund/adjustment/transfer of the fee once paid will be on a case-to-case basis depending upon School policy.
14	Annual Function Chagres of Rs 550 to be collected annually in August.
15	School Magazine charges of Rs 350 to be collected annually in October.
16	ID card fee of INR 50 to be collected Annually in July.
17	Please note that CBSE Board/ registration fee is payable in month of August/ September for Grade 9, 10, 11 & 12 registrations.
18	Alumni Member charge of Rs. 500 will be charged at the time of withdrawal. An administrative charge of RS. 50 will be charged for the TC at the time of withdrawal.
19	School messaging is done on the ERP application and all Parents must download the application and understand its working. Parents must also be comfortable using the internet, or having someone to assist them for this.
